Both options include some C&C cover, subject to your age category, with additional cover available on request. Your Travel Agent who books your flights may be able to assist with travel insurance. Alternatively, contact the AIG Call Centre on 0860 100 491 to arrange travel insurance with them. Travellers may be required to provide details of their travel insurance.

**GENERAL TERMS & CONDITIONS – PANNELL’S TOURS T/A CUSTOM TOURING**

**RESERVATIONS:** A Booking Form should be completed, signed and returned to Custom Touring. A 30% deposit is payable by 31 October and is refundable until 31 December, after which it reverts to non refundable. Full payment of the balance is due by 10 April 2021.

**ADDITIONAL FEES:** May be levied for name change after final payment.

**TOUR PRICE:** Prices quoted are based on land costs, hotel rates and cruise costs as at 10 July 2020. Should it be necessary to use alternative hotels, Custom Touring reserves the right to adjust prices if necessary. The same applies to Government Taxes, Sales Tax, VAT and third party services or any other circumstances beyond our control.

**METHOD OF PAYMENT:** Payment should be made by direct bank transfer. Payment by credit card not available.

**TOUR CANCELLATION & ALTERATION OF ITINERARY:** In accordance with standard procedure of tour operators worldwide, we reserve the right to cancel the tour should there be insufficient numbers, in which event all payments received will be refunded without any further obligation on the part of Custom Touring. We are not responsible for any other travel arrangements affected due to our cancellation. Whilst every effort will be made to keep to the published itinerary, we reserve the right to make changes to the programme and to substitute hotels of the same category, should unforeseen circumstances make this necessary. In the event of a tour having to be curtailed or extended, due to changes in transport schedules, any resultant expenses will be borne by the passenger and any saving refunded.

**PASSENGER CANCELLATION & REFUNDS:** All cancellations must be made in writing and will be subject to the following cancellation charges:

From 01 Jan 2021 to 10 April 2021, the deposit is forfeited.

From 10 April 2021, once final payment is made, 100% of total tour price is forfeited.

**INSURANCE:** All tour participants are required to take out comprehensive travel insurance covering personal accident, medical and emergency travel expenses, cancellation and curtailment, operator or airline default, loss of luggage and personal effects. Details of your Travel Insurance Policy may be required subsequent to booking.

**TRAVEL DOCUMENTS:** All passengers are personally responsible for ensuring they are in possession of the correct travel documents, visas or re-entry documents, where necessary. For this tour, visas are included and visa fees have been waived. Final tour documentation and vouchers for land arrangements will be prepared only on receipt of full and final payment.

**HEALTH REGULATIONS:** It is the passenger’s responsibility to check with a doctor or local travel clinic whether there are any specific health requirements for the relevant destination/s.

**SMOKING:** For escorted tours, smoking is not permitted on the coach, in restaurants, or anywhere the group will be dining together, including outdoors.

- **Activities:** Custom Touring shall under no circumstances whatsoever be responsible or in any way be held liable for injury, disability or death arising from participation in any of the activities on our tours.
